THERE ARE TWELVE (12) OFFICES LOCATED IN CHESTER, CROMWELL, DURHAM, EAST HADDAM, ESSEX, MADISON, MIDDLETOWN, OLD SAYBROOK, PORTLAND, AND WESTBROOK, CT.

IN MARCH 2020, THE PRESIDENT OF THE UNITED STATES ISSUED A PROCLAMATION DECLARING A NATIONAL EMERGENCY CONCERNING THE NOVEL CORONAVIRUS (COVID-19) OUTBREAK. MHS PRIMARY CARE CONTINUED TO BE A VITAL SUPPORT TO THE COMMUNITY AS IT STRUGGLED WITH COVID-19 AND CONTINUED TO PROVIDE CARE TO ALL PATIENTS EITHER IN PERSON OR THROUGH VIRTUAL VISITS.

MHS PRIMARY CARE'S ACTIVITIES EXPANDED DURING THE YEAR TO AID WITH THE INTERNATIONAL PANDEMIC SURROUNDING COVID-19. ASIDE FROM BEING ON THE FOREFRONT OF MAINTAINING ALL CDC PROTOCOLS TO PROTECT PATIENTS DURING THE CRISIS, MHS PRIMARY CARE HELPED THE COMMUNITY THROUGH TESTING.
